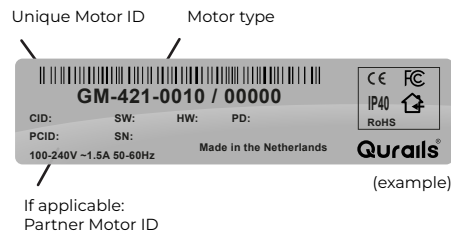
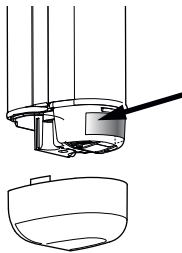

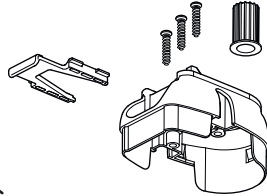
Qurails G-Motion is an electrical curtain rail motor designed to automate the Qurails 6200, 6500 and 6700 curtain rail systems, enabling automatic movement of the curtains. The system can be customized according to customer requirements, offering a choice of three different motor types and three additional add-on modules, as well as the option of either 24VDC or 100-230VAC power sources. The 100-230VAC models come with a built-in 24VDC power supply. Other than that, the 100-230VAC motors are identical to the 24VDC versions. The G-Motion system can be controlled using traditional dry contact signals, as well as through IR and RF control options. It can also be connected to a Sun/Dawn sensor. The Curtain Control Module (CCM), which serves as the electronic core of the product (highlighted in yellow), is included by default in every system. The RF module (highlighted in green) is an optional add-on that allows the system to receive RF signals from a remote control, enabling remote operation. Please note that the RF module is not included by default in the G-Motion system. While the G-Motion system can be used with a single motor, for simultaneous control of multiple motors, the RS485 module (highlighted in orange) must be used to facilitate communication between motors/systems. The RS485 module is not included by default in the G-Motion system. Additionally, the 100-230V switching device (highlighted in blue) is a separate add-on that can be integrated with the G-Motion motors to enable traditional 100-230VAC potential-powered switching control. Multiple add-ons can be incorporated either simultaneously or separately, but this process should be performed exclusively by Qurails B.V. or authorized companies.

The G-Motion Motors are developed, designed, assembled and tested in The Netherlands.

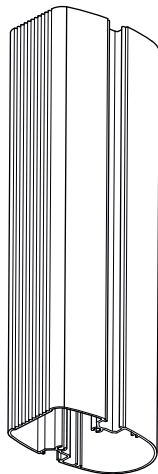

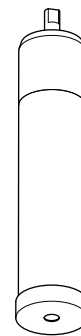
